# RULES AND REGULATIONS FOR THE TOM SAWYER RAFT RACE

- AWARDS:** TROPHIES WILL BE AWARDED TO THE FIRST 3 PLACES WITH ADDITIONAL TROPHIES FOR MOST ORIGINAL.
- AGE:** BOTH CONTESTANTS MUST HAVE ATTAINED THEIR 8TH BIRTHDAY BUT NOT THEIR 13TH BIRTHDAY BY THE DATE OF THE RACE.
- CREW:** TWO CONTESTANTS PER RAFT
- PROPULSION:** BY PADDLE OR POLE
- RAFT:** MUST BE HOMEMADE
- FLOTATION DEVISE:** EACH CONTESTANT MUST WEAR A COAST GUARD APPROVED LIFE PRESERVER.
- ENTRY FEE:** COST FOR EACH RAFT ENTERED IS \$10.00. PAYMENT CAN BE MAILED WITH THE ENTRY FORM TO THE JONESVILLE BUSINESS ASSOCIATION, 227 E. CHICAGO ST., JONESVILLE, MI 49250.
- TIME:** THE REECE STARTS AT 3:00PM. ALL CONTESTANTS MUST BE REGISTERED 30 MINUTES PRIOR TO THE START.
- DISQUALIFICATIONS:** ANY TEAM RECEIVING HELP AFTER THE START OF THE RACE WILL BE DISQUALIFIED. THE RAFT MUST STAY IN THE WATER FROM THE STARTING LINE TO THE FINISH LINE. THE RAFT MUST BE SUPPORTING BOTH CONTESTANTS AT THE FINISH LINE.
- WEATHER:** RAIN OR SHINE
- PARENT/GUARDIAN CONSENT:** ALL CONTESTANTS MUST HAVE THEIR PARENTS SIGN THE CONSENT FORM PRIOR TO THE START OF THE RACE.
